MONTHLY COMMENTS

February, European stocks generally outperformed their US counterparts; the dominating factor, however, was the 4.7% decline in A\$ versus US\$ and 2.0% versus €. Within the portfolio News Corp declined 15.6% after talks to sell the Move real estate platform in the USA were terminated against a backdrop of below expected results to 31 December 2022. Conversely, Madison Sq. Garden Entertainments rose as the opening of the Sphere project in Las Vegas becomes more certain whilst earnings from the current business were strong. During the month we added both Vivendi and Bollore to the portfolio given their extreme discount to intrinsic value and ongoing movement within the Bollore stable in its 200th year. We also added the new "top" company Brookfield Corporation based on its dscount to the value of the underlying corporate holdings in the Brookfield stable.
